Kids Karate



Karate is now a school year program, no obligation in the summer. Classes are 45 minutes in length and are appropriate for kids age 3-8. Monthly tuition is \$70 for members and \$90 for non-members. Karate payments are non-refundable and non-transferrable. Tuition fees do not vary for longer/shorts months, absences or cancellations. The Weymouth Club requires an Electronic Funds Transfer (EFT) form for each Karate student. Tuition will be automatically deducted from a designated account on the 2nd of every month. This will sign you up for the entire school year. If at any point you need to opt out of the program, simply send us a letter by the 20th of the month to stop payments (ex. If stopping in Nov, we need to know by Oct 20th.) Our program offers a 10% monthly discount for siblings!
