## PROGRAM REFUND/CREDIT POLICY

(1) ALL PARTICIPANTS AND THE INSTRUCTOR WILL AGREE UPON THE DATE AND TIME OF THE LESSONS. (2) **WHEN CANCELLING OR RESCHEDULING, 24 HOUR NOTICE IS REQUIRED. IF PARTICIPANT OR GUARDIAN IS UNABLE TO PROVIDE SUFFICIENT NOTICE, THE WEYMOUTH CLUB RESERVES THE RIGHT TO CHARGE THE PARTICIPANTS FOR THE LESSON TO COMPENSATE THE INSTRUCTOR REGARDLESS OF THE CANCELLATION REASON.** (3) IF PART OF A SEMI-PRIVATE LESSON DOES NOT ATTEND THEIR SCHEDULED LESSON TIME, AN INDIVIDUAL LESSON MAY BE PURCHASED FOR THE PRESENT PARTY. IF THE PRESENT PARTY DOES NOT WISH TO PURCHASE A SINGLE LESSON, BOTH PARTIES WILL BE CHARGED FOR THE SCHEDULED LESSON, DUE TO THE CLUB'S CANCELLATION POLICY. (4) IF THE INSTRUCTOR IS UNABLE TO ATTEND THE SCHEDULED LESSON, THE LESSON MAY BE CANCELLED WITHOUT CHARGE AT THE PARTICIPANT'S REQUEST. (5) IF THE LESSON IS CANCELLED DUE TO INCLEMENT WEATHER, LESSONS MAY RESUME ON THE NEXT SCHEDULED DAY/TIME AT NO EXTRA CHARGE. (6) IN ORDER TO SECURE YOUR CURRENT/DESIRED INSTRUCTOR, DAY, AND TIME, ADDITIONAL LESSONS MUST BE PURCHASED BEFORE THE LAST SCHEDULED LESSON IS USED IN THE CURRENT PACKAGE. (7) FUNDS ARE TRANSFERABLE TO FAMILY MEMBERS AND MUST BE USED FOR AQUATIC PROGRAMS ONLY, THIS INCLUDES GROUP TO PRIVATE LESSONS OR PRIVATE TO GROUP LESSONS. (8) PRIVATE LESSONS AND DEPARTMENT CREDITS EXPIRE 12 MONTHS FROM DATE OF PURCHASE.
